The income and properties of this TRUST shall be applied solely for the promotion and fulfillment of the aims and objects of the this TRUST. Provided if any donor intends that his or her contribution, donation or subscription shall be applied to the action meant for any particular object or objects of the this TRUST. Such contribution, donation or subscription shall be spent towards the promotion of that particular object or objects only.

The TRUST may raise loans from any of the financial institutions including Banks, Financial Corporations or other financial institutions to take up the projects and carry out the activities of the Trust. For this, the TRUST can create encumbrance on the properties of the TRUST by way of pledge, mortgage, lien etc.,

07. MEMBERSHIP:

Fifteen founder trustees as listed in the Para - I above are the permanent life member of this TRUST. Any other persons along with founder trustees shall be enrolled as members of this trust by Paying Rs.50,000/- (Rupees Fifty thousands only) as membership fees. However, any member or members owing to long illness, death or otherwise shall be filled in by his / her next of kin who shall be opted as members of this trust. Provided he/she has full faith in the trust and with the consent of the majority of the members of this TRUST.

08. BOARD OF TRUSTEES :

The first Board of the Trustees shall consist of the following members who shall be members of this Trust. At no time the number of Trustees shall not exceed Fifteen. The Board of Trustees shall consist of

- (a) President
- (b) Vice President
- (c) Secretary
- (d) Treasurer

Trustees will carry on the work and the properties both moveable and immovable of the Trust shall vest in the remaining Board of Trustees.

For the proper conduct of the affairs of this Trust the Board of Trustees shall hold meeting as and when necessary, but there shall be at least one meeting in every month and it shall keep proper records of all proceedings of such meetings. 2/3 of the Board of Trustees shall be the quorum for the Board meeting.

The Board of Trustees shall spend out of the funds or income of this Trust for the fulfillment of the objects of this Trust according to the Budget as sanctioned by the Annual General Meeting.

The Board of Trustees shall appoint and whenever necessary dismiss any paid servant or paid official for the welfare of this Trust.

The Board of Trustees may frame Rules and Bye-laws not inconsistent with the Rules and Regulations hereof for the Internal management of this Trust and for the conduct of its meeting and may alter or amend the same whenever necessary.

If any Trustee/Trustees express his desire to tender resignation for the Trusteeship before the expiry of his term, he shall have to give at least one month prior notice in writing to the Executive Body of this Trust and in case he himself is the president of this Trust then he has to give 3 months prior notice in writing to the Executive Body of this Trust. Such a letter of resignation will be placed before the meeting of Board of Trustees specially convened for this purpose within one month from the date of receipt of the Resignation. No resignation shall be deemed to be accepted until it is accepted at the said meeting. Similar procedure will be followed in case of filling of any casual vacancy due to death or incapacity of

12. MEETINGS OF THE EXECUTIVE BODY:

- 1) Executive Body shall generally meet once in a month (date, time and place shall be fixed by the President) to transact all business of the Trust as mentioned in the agenda. The Secretary shall issue a letter under his signature convening a meeting of the Executive body as per the desire of the President.

However, such non members of the Board shall have no power to caste vote at the meeting.

13. PROCEEDINGS OF THE ANNUAL GENERAL BODY MEETING:

- 1) The General Body Meeting of the Trust will be held on a date to be decided by the Board of Trustees not later than four months after the Date of Financial year of the TRUST. Necessary notice to all the members to be issued 15 days in advance by the Board of Trustees. The Notice will be in English or in Kannada mentioning the date, time and the place and the Agenda of the Meeting.
- 2) The business of the Annual General Body Meeting of this TRUST ;
 - a) To consider and pass the Annual Report presented by the President of this TRUST on behalf of the Board of Trustees.


c) To consider any other matter brought before the meeting either by the Board of Trustees or by the member present at the meeting concerning the Management and welfare of the TRUST.

14. A NOTICE:

A seven days clear notice shall be issued to all the fifteen members of the executive body mentioning the place, date and time of the meeting and also the agenda of the business to be transacted in the said meeting.



- 1) The quorum for the executive body meeting shall be 2/3rd members of the executive body. If, within half an hour of the appointed time on the appointed day of the meeting, there is no quorum, the meeting shall be adjourned to another time or date to be fixed by the President. In his absence Vice-President in consultation with the members present in the meeting. For the adjourned meeting no quorum is necessary for transacting the same agenda/business. For the adjourned meeting no notice shall be served personally or by post, which shall be notified on the notice board of the office of the TRUST. - 2) Every member will have one vote, Every resolution of the meeting of the TRUST shall be determined by the majority of the members present,. - 3) Attendance Book shall be kept and as for as possible it should be signed by all the members present at the meeting of the TRUST. The proceedings of all meetings of the TRUST shall be duly and properly recorded or caused to be recorded in the proceedings book either in Kannada or in English or in both by







- 4) An Extra Ordinary meeting of the TRUST shall be convened at such place and time as the Board of Trustees may deem fit. On the written requisition by at least 10 members showing the reason for calling the same then meeting shall convened within 15 days of the receipt of such requisition. One week notice to be served to the members for the purpose will suffice.
- 5) It shall be lawful for the TRUST at any Annual Meeting of the TRUST, duly convened for the purpose in the manner herein to amend, vary, alter, modify, or repeal all or any of the Rules and Regulations of the TRUST.

16. POWERS OF THE OFFICE BEARERS.

- a) President: He shall preside over all meetings. He shall be responsible for the smooth running of the TRUST. He shall help the TRUST in raising funds to the Trust as and when necessary. He shall be responsible for administrative and financial matters. He shall supervise all the activities and evaluate the results of the activities. When the votes are equal while taking decisions, the President shall have a casting vote which he can exercise.
- b) Vice-President: In the absence of the President, Vice President shall preside over all meetings of the Executive Body. He shall discharge generally all the duties so as to help the President in all his affairs of the TRUST. He shall assist in the smooth running of the TRUST.
- c) Treasurer: He shall be the custodian for all cash transactions. He shall ensure that all incoming cash is deposited in to the bank account in the name of TRUST. Bank account shall be jointly operated by the Treasurer and the Secretary. He shall checkup all accounts in detail. He shall ensure that for incoming cash proper receipt is issued by the Secretary. He shall be responsible for misappropriation of money belonging to the TRUST.

In the absence of the Treasurer, the president shall look after his duties including the operation of Bank Account, if the urgency arises.

d) SECRETARY: He shall be responsible for all routine working of the TRUST. He shall attend all the routine works of the TRUST. He shall be responsible for equipping and maintaining the TRUST'S office. He shall be the custodian of all documents, records, registers and files. He shall look after the routine correspondence of the TRUST. He shall be repressible for all the office bearers. He shall ensure that all accounts are maintained properly and leagally. He shall keep all receipt vouchers and expense vouchers in his custody. He shall issue official receipt for all incoming cash / DD and cheques. He shall make payments when the amount is sanctioned by the executive body. He shall convene meetings under his signature and maintain the minutes of the executive body meetings. He shall present the progress report to the executive body every month in the meeting of the executive body. He shall also ensure that all the employees of the TRUST are paid their salary on the first day of each month.

Proper salary bills shall be prepared by his office. All routine payment vouchers shall be signed by Secretary. Non-routine payment voucher are jointly signed by the Treasurer and the Secretary. He shall operate the bank account jointly (Secretary and the Treasurer). Ordinary letters of correspondence can be signed by the Secretary. However, important letters may be sent under the signature of the President / Vice-president. He shall look after the welfare and well being of the employees of the TRUST. He shall ensure that the salary of the members of the staff is fixed by the executive body of the TRUST. He shall ensure that proper accommodation, furniture, stationery and other equipment are provided to all sections of the TRUST as per the requirement. In a nut shell he shall be the key person to the TRUST. All property shall be looked after by them. He shall prepare annual progress report and balance sheet and receipt and payment statement.

19. FINANCIAL YEAR:

The financial year shall be from 1st April to 31st March every year.

20. ACCOUNTS AND AUDIT:

- b) Annual progress report of the TRUST shall also be presented before the meeting of the Annual General Body along with audited statements showing receipt and payment and balance sheet for approval.

21. INVESTEMENT CLAUSE:

The funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act,1961 as amended from time to time and such other provisions of such law(s) as may be in force from time to time.

22. AMENDMENT CLAUSE:

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income –Tax Act, 1961, as in force from time to time. Further, no amendment shall be carried out without the approval of the Commissioner of Income-Tax or such authority/authorities as may be required as per law in force from time to time.

The funds and income of the Trust shall be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to the Trustees/ Members by way of profit or dividend etc.,


23. DISSOLUTION CLUSE:
