





**06. BORROWINGS**

However, any member or members owing to long illness, death or otherwise shall be filled in by his / her next of kin who shall be opted as members of this trust. Provided he/she has full faith in the trust and with the consent of the majority of the members of this TRUST.

**08. BOARD OF TRUSTEES :**

The first Board of the Trustees shall consist of the following members who shall be members of this Trust. At no time the number of Trustees shall not exceed Fifteen. The Board of Trustees shall consist of



Trustees will carry on the work and the properties both moveable and immovable of the Trust shall vest in the remaining Board of Trustees.

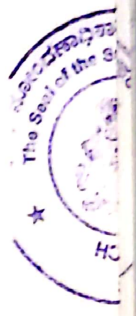

The Board of Trustees shall spend out of the funds or income of this Trust for the fulfillment of the objects of this Trust according to the Budget as sanctioned by the Annual General Meeting.

The Board of Trustees shall appoint and whenever necessary dismiss any paid servant or paid official for the welfare of this Trust.

The Board of Trustees may frame Rules and Bye-laws not inconsistent with the Rules and Regulations hereof for the Internal management of this Trust and for the conduct of its meeting and may alter or amend the same whenever necessary.

If any Trustee/Trustees express his desire to tender resignation for the Trusteeship before the expiry of his term, he shall have to give at least one month prior notice in writing to the Executive Body of this Trust and in case he himself is the president of this Trust then he has to give 3 months prior notice in writing to the Executive Body of this Trust. Such a letter of resignation will be placed before the meeting of Board of Trustees specially convened for this purpose within one month from the date of receipt of the Resignation. No resignation shall be deemed to be accepted until it is accepted at the said meeting. Similar procedure will be followed in case of filling of any casual vacancy due to death or incapacity of Trustees.

The Executive body of this trust shall be the elected body in the Annual General Body meeting of the members. The term of such elected Executive Body shall ordinarily be for five years. Before the expiry of the term, If the members of this TRUST decides they can elect new Executive Body or new TRUSTEES and office bearers.

- b) Vice-President : In the absence of the President, Vice President shall preside over all meetings of the Executive Body. He shall discharge generally all the duties so as to help the President in all his affairs of the TRUST. He shall assist in the smooth running of the TRUST.
- c) Treasurer : He shall be the custodian for all cash transactions. He shall ensure that all incoming cash is deposited in to the bank account in the name of TRUST. Bank account shall be jointly operated by the Treasurer and the Secretary. He shall checkup all accounts in detail. He shall ensure that for incoming cash proper receipt is issued by the Secretary. He shall be responsible for misappropriation of money belonging to the TRUST.

In the absence of the Treasurer, the president shall look after his duties including the operation of Bank Account, if the urgency arises.

**21. INVESTEMENT CLAUSE :**

The funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act,1961 as amended from time to time and such other provisions of such law(s) as may be in force from time to time.

**22. AMENDMENT CLAUSE :**

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income –Tax Act, 1961, as in force from time to time. Further, no amendment shall be carried out without the approval of the Commissioner of Income-Tax or such authority/authorities as may be required as per law in force from time to time.

The funds and income of the Trust shall be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to the Trustees/ Members by way of profit or dividend etc.,

**23. DISSOLUTION CLUSE :**

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/ Members of the Managing Committee/Governing Body. But the same shall be transferred to another Charitable Trust / Institutions/ Society whose objects are similarly to those of this Trust and which enjoys similar recognition under Section 80G of the Income Tax Act, 1961 as amended from time to time.

**24. LEGAL PROCEEDINGS :**

**25. AMENDEMENT OF CONSTITUTION OF THE TRUST.**

**27. GENERAL**

- 01) Shall have power to pledge, mortgage, transfer OR alienate any of the TRUST property/properties in the better interest of the TRUST. The executive body of the TRUST shall have power to grant aid to the needy institutions established by the trust by way of grant, donations, loans and advances etc., in consultations with the executive body of the TRUST.
- 02) No amendments, alterations or repeals shall be made to the constitution and the working rules of the TRUST which may prove to be repugnant to the provisions of the INDIAN TRUSTS ACT, 1882 and the provisions of the Sections 2(15) 11 to 13 and 80-G of the Income – Tax Act, 1961, for the time being in force a s and when applicable.
